#### Senate

Hearing: Oversight of the Airline Industry. On December 15, the Commerce, Science and Transportation Committee held an oversight hearing on the airline industry. The hearing examined the impact of the \$54 billion that was provided in Payroll Support Program funding to the commercial airline sector, focusing on it had on the industry's workforce, and the effect of airline operational performance on passengers. The airline CEOs all expressed support for the federal government's actions, arguing those funds saved the airline industry. The flight attendants highlighted the problems its members are having with unruly passengers, calling for stricter federal penalties. There also was an exchange between Senator Ted Cruz (R-TX) and Senator Gary Peters (D-MI) over the vaccine mandate for large companies. Witnesses included representatives of American, Delta, United and Southwest Airlines, as well as Association of Flight Attendants, and InterVISTAS Consulting Inc. Information on the hearing is here.

*FHWA: IIJA Highway Authorizations*. The Federal Highway Administration has published the program authorizations for fiscal years 2022-26, pursuant to the Infrastructure Investment and Jobs Act. The \$52.5 billion in apportioned funding for FY 2022 is an increase of more than 20 percent over FY 2021. This funding is distributed annually by FHWA based on a statutory formula contained in the IIJA. FHWA is distributing these funds through a process known as an apportionment, using a statutory formula to determine the amount available to each State. *FAA: IIJA Airport Grant Awards.* The Federal Aviation Administration has announced that it has awarded \$2.89 billion in airport grant funds that were provided by Congress in the IIJA. This is the first year installment of the IIJA Airport Improvement Program (AIP) grant funds. Funding will go to 3,075 airports around the nation and the funds can be invested in runways, taxiways, safety and sustainability projects, as well as terminal, airport-transit connections and roadway projects.
