

2026 STATE ADVOCACY PROGRAM

The District will pursue policies and actions that support its mission "to deliver safe, reliable, sustainable transit service that responds to the needs of our customers and communities."

DISTRICT SPONSORED LEGISLATION

- 1. Sponsor legislation that extends indefinitely transit agencies' existing authority to enforce parking violations in transit-only zones using automated, forward-facing camera technology.
- 2. Sponsor legislation that exempts transit operators from state sales taxes when purchasing zero emission buses.
- 3. Sponsor legislation ensuring public transit agencies with independently elected governing boards have a voting seat(s) on the Board of a Metropolitan Planning Organization.

2026 STATE ADVOCACY PRIORITIES

Identify and secure long-term funding for...

- 1. The delivery of safe, reliable, and affordable public transportation that is accessible to all
- 2. Workforce recruitment, training, development, retention, safety, and well-being
- 3. Transit and maintenance operations, paratransit program needs, priority capital projects, and ridership growth
- 4. Addressing the District's projected operating deficits
- 5. Sustaining and growing state investments in transit infrastructure, buses, and amenities
- 6. Supplementary service to schools and student transit pass programs
- 7. Investments that protect and enhance the resiliency of the District's physical, cybersecurity, operational, and human assets
- 8. Achieving compliance with the Innovative Clean Transportation (ICT) and other mandated regulations
- 9. Efforts that seek to coordinate, integrate, and streamline public transit in the region
- 10. Our priorities in the State's Cap-and-Invest Program extension
- 11. Feeder service to BART

Advocate for transit-supportive laws, regulations, actions, and policies that...

- 1. Provide the means needed to ensure the District's financial sustainability
- 2. Support transportation workforce development, training, and safety
- 3. Respond to customer needs and grow transit ridership

- 4. Support innovative technology initiatives, partnerships, and investments that benefit public transit and grow ridership
- 5. Secure new and existing funding streams and which equitably allocate those funds to support the District's transportation infrastructure and services
- 6. Reduce or remove regulatory barriers to efficiently develop and deliver District projects and services
- 7. Avoid new, unfunded mandates and regulations
- 8. Advance transparent and accountable governance
- 9. Support the movement of buses and paratransit vehicles on local roads and state highways
- 10. Ensure safe, accessible transportation for all users while minimizing District risk and liability.
- 11. Promote public transit in local, regional, and state planning, project development, and land use decisions
- 12. Seek to coordinate, integrate, and streamline public transit while encouraging ridership
- 13. Support the District's clean propulsion technology bus and paratransit service
- 14. Improve street safety to reduce traffic-related incidents/accidents
- 15. Update and modify the State Transportation Development Act (TDA) & State Transit Assistance (STA) Program formulas
- 16. Amend the Innovative Clean Transit regulation's *Zero Emission Bus Purchase Schedule* to reflect reasonable timelines based on funding availability and manufacturer constraints
