AMENDMENT TO THE AMENDMENT: McCALLEY/SHAW to reject the censure of Director Syed; require additional training for the entire Board; require additional Board governance, leadership and coaching for Director Syed and make coaching available to all Board Officers.

General Counsel Aimee Steele gave a brief presentation along with the options available for the Board to consider. In addition, Director Syed responded to the allegations of violating Board Policies 101 and 702 (a memo from Director Syed outlining her position is incorporated into the record by reference).

Public Comment:

The following speakers opposed the proposed resolution 25-006 to censure Director Sarah Sved for violations Board Policies 101 and 702. They argued that the censure appeared particularly in response to her comments on former GM Hursh's exit package. They defended Syed's role as a transit advocate for her constituents and emphasized that directors should have the freedom to ask questions. Speakers also felt that censuring her would send a negative message, single her out unfairly, and contrast poorly with past censures for more serious infractions. They suggested that the board should focus on more pressing issues, such as the upcoming budget and increasing transit ridership, instead of censure. Additionally, they highlighted that an investigative report recommended training rather than censure, and called for a cultural shift in the board where disagreements don't lead to punitive actions.
