RESOLUTION NO. 24-007**

**A RESOLUTION APPROVING THE NEW CLASSIFICATIONS OF DEPUTY EXECUTIVE OFFICER RETIREMENT PLAN, SENIOR RETIREMENT PLAN ANALYST, AND RETIREMENT PLAN ASSOCIATE ANALYST AND THE REVISED CLASSIFICATIONS OF EXECUTIVE OFFICER RETIREMENT PLAN, PRINCIPAL RETIREMENT PLAN ANALYST, RETIREMENT PLAN ANALYST, AND RETIREMENT PLAN ASSISTANT ANALYST.**

**WHEREAS**, Public Utilities Code Section 24886 authorizes the Board of Directors of the Alameda-Contra Costa Transit District to determine and create such number and character of positions in the District as are necessary to carry on the functions of the District; as well as to establish the appropriate salary, salary range or wage for each classification created by the District; and

**WHEREAS**, the General Manager has assessed the current personnel needs of the District and determined amendments to the classification plan are necessary for the proper operation of the District; and

**WHEREAS**, the Board of Directors has reviewed and considered the recommendation of the General Manager to adopt the new classifications Deputy Executive Officer Retirement Plan, Senior Retirement Plan Analyst, and Retirement Plan Associate Analyst and the revised classifications of Executive Officer Retirement Plan, Principal Retirement Plan Analyst, Retirement Plan Analyst, and Retirement Plan Assistant Analyst.

**NOW THEREFORE**, the Board of Directors of the Alameda-Contra Costa Transit District does resolve as follows:

**Section 1.** Adopts the new classifications of Deputy Executive Officer Retirement Plan, Senior Retirement Plan Analyst, and Retirement Plan Associate Analyst in Exhibits A, B, and C and the revised classifications of Executive Officer Retirement Plan, Principal Retirement Plan Analyst, Retirement Plan Analyst, and Retirement Plan Assistant Analyst in Exhibits D, E, F, and G of this Resolution.

**Section 2.** This resolution shall become effective immediately upon its passage by four affirmative votes of the Board of Directors.
