- 3. Addressing the District's projected, pandemic-induced operating deficits
- 4. School transportation operations and student transit pass programs
- 5. Sustaining and growing state investments in transit infrastructure
- 6. Maintaining a state of good repair
- 7. Investments that protect and enhance the resiliency of the District's physical, cybersecurity, operational, and human assets
- 8. Comprehensive sustainability initiatives, including but not limited to zero emission bus and paratransit program needs
- 9. Workforce recruitment, training, development, retention, safety, wellness, and well-being
- 10. Achieving compliance with the *Innovative Clean Transportation* (ICT) regulation and other state mandated regulations
- 11. Efforts that seek to coordinate, integrate, and streamline public transit in the region

- 1. Provide the means needed to ensure the District's fiscal integrity
- 2. Respond to customer needs and result in increased transit ridership
- 3. Create new funding streams to support transportation infrastructure and services
- 4. Support innovative technology initiatives, partnerships, and investments that benefit public transit and increase ridership

- 7. Prioritize the movement of buses and paratransit vehicles on local roads and state highways
- 8. Encourage the use of public transportation and disincentivize the use of personal vehicles
- 9. Prioritize public transit in local planning, project development, and land use
- 10. Seek to coordinate, integrate, and streamline public transit while encouraging ridership
- 11. Require direct representation of transit districts on the Metropolitan Transportation Commission's (MTC) governing board
- 12. Support the provision of zero emission bus and paratransit vehicle service
