INDEPENDENT ACCOUNTANT'S REPORT

Board of Directors Alameda-Contra Costa Transit District Oakland, California

We have examined the Alameda-Contra Costa Transit District's (the District) compliance with the requirements described in the Measure J Cooperative Agreement (the Agreement) between the District and the Contra Costa Transportation Authority (CCTA) applicable to the Measure J Funds that were allocated to the District for the year ended June 30, 2023. Measure J sales tax revenues and related expenses for the year ended June 30, 2023 are included in the accompanying Schedule of Revenues and Expenses. Management of the District is responsible for the District's compliance with the specified requirements. We believe that the evidence we obtained is sufficient and appropriate to provide a reasonable basis for our opinion.

We are required to be independent and to meet our other ethical responsibilities in accordance with relevant ethical requirements relating to the engagement.

Our examination does not provide a legal determination on the District's compliance with specified requirements.

In our opinion, the District complied, in all material respects, with the aforementioned requirements that are applicable to the Measure J Funds as specified in the Agreement for the year ended June 30, 2022.
