A RESOLUTION AUTHORIZING THE INTERIM GENERAL MANAGER OR HER DESIGNEE TO FILE AND EXECUTE APPLICATIONS AND FUNDING AGREEMENTS WITH THE CALIFORNIA DEPARTMENT OF TRANSPORTATION FOR ALLOCATIONS OF FY2024-25 LOW CARBON TRANSIT OPERATIONS PROGRAM (LCTOP) FUNDS FOR THE OPERATING ASSISTANCE FOR THE TEMPO SERVICE AND FRUITVALE CORRIDOR TRANSIT SIGNAL PRIORITY PROJECTS; AND TO PROVIDE CERTIFICATIONS AND ASSURANCES, AND ASSIGN THE INTERIM GENERAL MANAGER, OR HER DESIGNEE, AS THE AUTHORIZED AGENT

WHEREAS, the Alameda-Contra Costa Transit District (District) is an eligible project sponsor and may receive funding from the Low Carbon Transit Operations (LCTOP) Program for transit projects; and

WHEREAS, the statutes related to state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, Senate Bill 862 (2014) named the Department of Transportation (Department) as the administrative agency for the LCTOP; and

WHEREAS, the Department has developed guidelines for the purpose of administering and distributing LCTOP funds to eligible project sponsors (local agencies); and

WHEREAS, the District wishes to delegate authorization to execute these documents and any amendments thereto to the Interim General Manager, Kathleen Kelly, or her designee.

NOW THEREFORE, the Board of Directors of the Alameda-Contra Costa Transit District does resolve as follows:

Section 1. The District as the fund recipient agrees to comply with all conditions and requirements set forth in the Certification and Assurances and the Authorized Agent documents and applicable statutes, regulations and guidelines for all LCTOP funded transit projects.

<u>Section 2.</u> Authorizes Interim General Manager, Kathleen Kelly, or her designee, to execute all required documents of the LCTOP program and any Amendments thereto with the California Department of Transportation.

Section 3. Authorizes the following project nominations and allocation requests for the FY 2024-25 LCTOP funds:
