I am currently a member of the following advisory committees:

AC Transit Lived Experience Advisory Group: As a resident of Fremont and an AC Transit bus rider, I am representing Ward 5 on this committee. As part of AC Transit's Realign process, I provide feedback on my own experience riding AC Transit and the experiences of other AC Transit riders in Southern Alameda County. In particular, I am helping to address how bus route changes (for example, line 215) will affect the community. I also try to advocate for bus service in areas where there is housing development planned, especially denser housing that is targeted to low-income families and seniors.

Ride-On Tri-City! Accessibility Advisory Committee: As a rider with the Ride-On Tri-City Program, I am part of this committee that helps to advise City of Fremont, Newark and Union City staff on the operations of their Measure BB funded specialized transportation program in order to improve service for older adults and people with disabilities.

I have also been invited to join a focus group to discuss the future of transportation throughout the San Francisco Bay Area; this focus group is being organized by the Metropolitan Transportation Commission. I am awaiting a response from MTC.

I am very interested in joining PAPCO.
