The Alameda-Contra Costa Transit District Board of Directors held a special meeting on Monday, October 29, 2025, 2025, at 4:00 p.m.

Code Sections 54950, et seq.) and the provisions of Board Policy 101, Section 4.9 regarding teleconferenced meetings were met in order for Director Syed to participate in the meeting and advised that all votes must be taken by roll call vote.

President Shaw called the Board of Directors special meeting to order at 4:01 p.m.

Board Administrative Officer/District Secretary Linda Nemeroff reported that four individuals expressed an interest in filling the vacancy on the Board of Directors and that all had supplied the necessary information to be considered by the October 8th deadline. Ms. Nemeroff further advised that Alameda and Contra Costa elections offices had confirmed that all applicants making presentations during the meeting lived and were registered to vote within the Ward 1 geographical boundary. There was no public comment offered.

The Board of Directors heard initial presentations from four applicants vying to fill the seat on the Board.

Public Comment:

Estrella Sandberg supported Nick Pilch's appointment as Ward 1 Board Member, citing his dedication to public transportation, humility, and effectiveness, and urged endorsement of his candidacy.

George Spies, of Traffic Violence Rabbit Response, stressed the need for a Ward 1 representative who understands community transit needs and endorsed Nick Pilch and Joanna Pace. Other applicants were critiqued for not responding to a transit advocacy survey. Spies called for an engaged, rider-focused Board.

David Lyons, representing the People's Transit Alliance (PTA), noted that no applicants addressed ATU192 workers' conditions, such as inadequate meal or restroom breaks, which impact operator retention and service quality. He stated PTA's support for addressing funding shortfalls through a 2% gross receipts tax on the wealthy and endorsed Jovanka Beckles for the Ward 1 seat.

Anthony questioned Harpreet Sandhu's qualifications, referencing Sandhu's past Richmond City Council appointment and subsequent election loss as signs of weak voter support. Anthony argued that the new Board member should have proven electoral backing and a strong record of representing constituents, which Anthony believed the other candidates had demonstrated.

MOTION: SHAW/YOUNG to approve the selection of Harpreet Sandhu and Joanna Pace as finalists for the Ward 1 vacancy. The motion carried by the following vote:
