State Budget Advocacy	In response to the Governor's proposed budget, AC Transit joined a coalition of 60 transit operators and transportation advocates in sending a letter to Budget Chairs Skinner and Ting urging support for transit. The January 18 letter called on the legislature to honor the transit investments made in the current year's budget and requested new, multi-year funding in next year's budget to help stave off service cuts, layoffs, and attract riders back to transit.	Coalition letters demonstrate to policy-makers widespread support for transit funding and, in so doing, influence the policymaking process.
State Budget Advocacy	In March, AC Transit signed on to a letter with more than 100 other organizations urging legislators to fund transit operations in next year's budget. Federal Grant Support	Supported the successful application to the Federal Transit Administration's (FTA) FY23 Low- and No-Emission and Bus & Bus Facilities grant programs.	The District was awarded a \$25.5 million federal grant to purchase 25 Fuel Cell Buses and transform our Training & Education Center into the nation's foremost clean transit training facility. Nine letters of support from community-based organizations and all members of our federal delegation accompanied the submission.
Federal Grant Support	Supported the successful application to the FTA's 2023 Areas of Persistent Poverty grant program.	The District was awarded \$450,000 to support the community outreach needed to develop a plan for improved transit on Foothill Boulevard between Lake Merritt and the Eastmont Mall in Oakland. Several letters of support from the community, secured by District staff, helped secure this funding.

State Legislative Advocacy	Conceived of and co-sponsored Assembly Bill 463 (Hart) to grant transit agencies across the state with priority access to electricity during disruptions to the power grid.	Assemblymember Greg Hart (Santa Barbara) introduced AB 463, which quickly received support from transit operators across the state. The bill did not advance out of the Assembly Appropriations Committee, so the District and California Transit Association are exploring a possible regulatory fix through the California Public Utilities commission (CPUC).
State Legislative Advocacy	Helped shape and supported the passage of Senate Bill (SB) 125 , the Transportation budget trailer bill.	<p>SB 125 makes \$5.1 billion available to California's transit agencies, which can be flexed to fund transit operations or capital improvements. Four billion dollars will be provided over the next two fiscal years by way of the Transit & Intercity Rail Capital Program (TIRCP). The governor had originally proposed slashing this program by \$2 billion; \$1.1 billion more is committed over the next four years towards a new Zero-Emission Transit Capital Program.</p> <p>SB 125 also establishes a Transit Transformation Task Force, led by the California State Transportation Agency, to develop policy recommendations to grow transit ridership, improve the transit experience. and address long-term operational needs.</p>

State Legislative Advocacy	Advocated in support of SB 532 (Weiner) , which would increase tolls over Bay Area bridges by \$1.50 for a period of 5 years, generating approximately \$900 million for Bay Area transit. This includes meeting with Assemblywoman Ortega and the Office of Senator Wahab to encourage their support for the bill.	Senator Weiner paused SB 532 in August, stating that he will convene a working group of Bay Area legislators over the fall to determine what transit funding proposals to pursue in the next legislative session.
State Legislative Advocacy	Increased engagement on activities related to the introduction of legislation in 2024 that will authorize the region to place a transportation funding measure on the ballot in 2026.	Senator Weiner has indicated he wishes to sponsor this legislation during the 2024 legislative session.

State Legislative Advocacy	Advocated for passage of legislation supported by the District during in-person and virtual meetings with policymakers and their staff, at committee hearings, in writing, and via our advocate in Sacramento.	<p>Passed into law:</p> <ul style="list-style-type: none"> AB 645 establishes a five-year pilot program that gives several California cities, Oakland among them, the authority to install speed safety systems (e.g., automated cameras) aimed at slowing vehicle traffic. SB 434 requires the state's 10 largest transit agencies, including AC Transit, to survey riders about harassment on public transportation. The District will survey its riders in 2024. ACA 1 lowers to 55% the voter threshold for tax measures that could help fund capital improvements to transit. This constitutional amendment requires voter approval and will be on the 2024 General Election ballot. <p>Vetoed by the Governor:</p> <ul style="list-style-type: none"> AB 719 would have required managed health care plans to reimburse public transit agencies for the cost of providing non-medical transportation. Federal Appropriations Advocacy	This November, in coordination with the American Public Transportation Association (APTA) and The Bus Coalition, staff urged members of our Congressional delegation to oppose Republican amendments aimed at reducing funding for transit infrastructure grant funding and prohibiting the use of any federal funds for transit-oriented development.	All offices from our Congressional delegation affirmed that they would oppose these amendments, all of which ultimately failed.
Federal Advocacy	During APTA's annual legislative conference in Washington, DC, District representatives met with staff from all six members of our federal delegation (Senators Feinstein and Padilla, and Representatives Garamendi, Lee, Swalwell, and Khanna), in addition to the powerful House Appropriations Transportation Subcommittee .	These meetings offered a valuable opportunity to stress the importance of our service to their constituents, advocate for funding, highlight our leadership in zero emissions public transit, and to urge support for our earmark requests. Notably, Senator Padilla and Representatives Lee and Swalwell succeeded in inserting our earmark requests into their respective chamber's annual funding bills.
Federal Advocacy	In August, District representatives met with Congressman Swalwell's new legislative assistant to introduce her to AC Transit and provide an update on District priorities.	The meeting offered a valuable opportunity to cultivate a new relationship, stress the importance of our service to the congressman's district, advocate for funding, highlight our leadership in zero emissions public transit, and to urge support for our earmark requests.
Regional Policy Development	Supported launch of a joint AC Transit – MTC effort to develop of a regional transit priority policy, per the Blue Ribbon Transit Recovery Task Force's <i>Bay Area Transit Transformation Action Plan</i> . 2024 Report to Congress and the Legislature	The Department of Legislative Affairs & Community Relations composed and distributed to policymakers and their staff its annual Report to Congress and the Legislature . Printed copies were distributed to federal and state policymakers and their staff at in-person meetings, and digital copies were provided following online meetings.	The Report is a key advocacy tool that quickly and effectively summarizes the District's top priorities and needs. This year's report underscored the need for operations funding; urged support for District-sponsored legislation, AB 463 (Hart); and spotlighted our industry-leading ZEB program needs.
2024 Federal and State Advocacy Programs	Led development of the agency's annual federal and state advocacy programs, which guide the District's policy-related activities in Sacramento and Washington, DC. During our time together we showcased our initiatives and programs, visited the zero emission bus facilities at Division 2, and toured the Tempo BRT system, which received significant federal funding.
