## Background

- Staff routinely receive input from operators and field staff regarding runtime, layover, and run structure issues.
- These locations affect the quality of service for riders and quality of life for operators.
- Staff talked with operators and evaluated schedule data between 2019 and 2023 to identify trends and themes.
- This analysis informed a list of recommendations
- Goal: improve operator quality of life and service reliability.

# Layover Conditions

- ATU 192 CBA:
  - Layover is 10% of one-way running time + 4 minutes
- COVID-19 changed AC Transit service
  - Fewer revenue trips in 2023 than 2019
- Different operator experience at each Division
- System-wide layover higher in 2023 than in 2019, but lower than 2020.

- Earlier June Sign-up with rehang of runs
- Incentive pay for Trunk Line Operators
  - 1T, 6, 10, 18, 40, 51A, 51B, 57, 72/72M, 72R, 97, 99
  - Operator must drive the line to receive incentive pay
- Active monitoring for Service Operated KPI to achieve 98%
  - Lines that fail to meet mutual goal will be considered for removal from Incentive Pay eligibility
