RESOLUTION NO. 23-018**

**A RESOLUTION AUTHORIZING THE ALAMEDA COUNTY TRANSPORTATION COMMISSION TO  
APPROPRIATE \$2 MILLION OF MEASURE BB COLLEGE/BROADWAY CORRIDOR TRANSIT  
PRIORITY FUNDS TO THE CITY OF OAKLAND FOR CONSTRUCTION OF THE EXTENSION OF  
DEDICATED TRANSIT LANES ON BROADWAY TO JACK LONDON SQUARE**

**WHEREAS**, in 2014, Alameda County voters passed the Measure BB half-cent sales tax to improve transportation throughout the County; and

**WHEREAS**, the Measure BB Transportation Expenditure Plan, managed by the Alameda County Transportation Commission (ACTC), programmed \$10 million to AC Transit for College/Broadway Corridor Transit Priority; and

**WHEREAS**, in 2020, the City of Oakland completed construction of transit-only lanes on Broadway between 11<sup>th</sup> and 20<sup>th</sup> streets along AC Transit's busiest transit corridor; and

**WHEREAS**, in 2021, with AC Transit's support, the City of Oakland received a \$14.5 million Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant award for implementing its Reconnecting the Town: Safe Reliable and Equitable Access Project; and

**WHEREAS**, the City of Oakland's Reconnecting the Town Project includes transit improvements in West Oakland and Jack London Square, including the extension of dedicated transit lanes along Broadway; and

**WHEREAS**, the aforementioned project will require multiple funding sources to complete; and

**WHEREAS**, AC Transit has not yet detailed a plan or project to spend the remainder of the College/Broadway Corridor Transit Priority funds; and

**WHEREAS**, the extension of Broadway transit lanes is an eligible use of the \$10 million programmed for College/Broadway Corridor Transit Priority.

**NOW THEREFORE**, the Board of Directors of the Alameda-Contra Costa Transit District does resolve as follows:

**Section 1.** Approves the appropriation of \$2 million of the Measure BB College/Broadway Corridor Transit Priority funds to the City of Oakland for construction of the extension of dedicated transit lanes along Broadway to Jack London Square.

**Section 2.** AC Transit and City of Oakland will closely coordinate on the planning and design of the extension of the dedicated transit lanes and other transit elements included in the Reconnecting the Town Project.

**Section 3.** This resolution shall become effective immediately upon its passage by four affirmative votes of the Board of Directors.
