INTRODUCED BY COUNCIL PRESIDENT BAS

RESOLUTION DIRECTING THE CITY ADMINISTRATOR TO ACCEPT THE INVITATION FROM THE ALAMEDA-CONTRA COSTA TRANSIT DISTRICT (AC TRANSIT) TO PARTICIPATE IN INTER-AGENCY LIAISON COMMITTEE, WHICH WILL PROVIDE A COOPERATIVE FRAMEWORK AN FOR INPUT AND EXHANCGE OF INFORMATION TO IMPROVE SERVICE PLANNING COORDINATION BETWEEN AC TRANSIT AND THE CITY OF OAKLAND, AND APPOINTING CITY OF OAKLAND COUNCILMEMBER NOEL GALLO, COUNCILMEMBER _____ AND VICE MAYOR REBECCA KAPLAN AS THE CITY REPRESENTATIVES TO THE COMMITTEE, AND APPOINTING COUNCILMEMBER DAN KALB AS AN ALTERNATE

WHEREAS, the City of Oakland received an invitation from The Alameda-Contra Costa County Transit District (AC Transit) to form an Interagency Liaison Committee (ILC) to provide a cooperative framework to improve transportation service planning coordination between Oakland and AC Transit; and

WHEREAS, the ILC framework sets forth the purpose of ILCs, membership, the frequency of meetings and areas of mutual interest upon which collaborative efforts are based; and

WHEREAS, ILCs are intended to provide a cooperative framework to improve service planning coordination between AC Transit and local jurisdictions or agencies; and

WHEREAS, transit issues subject to these collaborative discussions include and are not limited to: new residential and commercial developments, roadway and right-of-way changes and projects, service planning including: routes, schedules and bus stops, service partnerships, transit corridor projects such as Rapid Bus and Bus Rapid Transit, area service plan proposals such as AC Go or Transbay Tomorrow and connections between multiple transit modes; and

WHEREAS, ILCs are Brown Act committees established by the AC Transit Board of Directors and a local jurisdiction; and

WHEREAS, the ILC is composed of three AC Transit Board Members and three partner agency city councilmembers; and

WHEREAS, decisions of the ILCs are non-binding on the District or partner agency, and the ILC does not have the authority to enter into agreements, contracts or other binding decisions on behalf of either organization; and

WHEREAS, the City Administrator is supportive of forming an ILC and has assigned Nicole Ferrera, Assistant to the Director of the Department of Transportation, to participate in the ILC; now, therefore, be it

RESOLVED: That the City Council directs the City Administrator to accept the Alameda-Contra Costa County Transit District (AC Transit) invitation to join the Interagency Liaison Committee (ILC) and to send a letter to AC Transit informing them of the Council’s desire to participate in the ILC in accordance with the framework established; and be it

FURTHER RESOLVED: That the City Council appoints Councilmember Noel Gallo, Councilmember _____ and Vice Mayor Rebecca Kaplan to the ILC as its representatives, and Councilmember Dan Kalb as an alternate, to participate and carry out the work and responsibilities of this committee.
