# SB 125 Recap

- SB 125 provides \$1.2B in state support for Bay Area transit operations and/or capital projects over 5 years
  - \$665M for capital projects
  - \$505M for operating support
- Complemented by \$300M regional contribution
- SB 125 operating funds support continued service provision
- SB 125 operating funds do not fund operator capital commitments



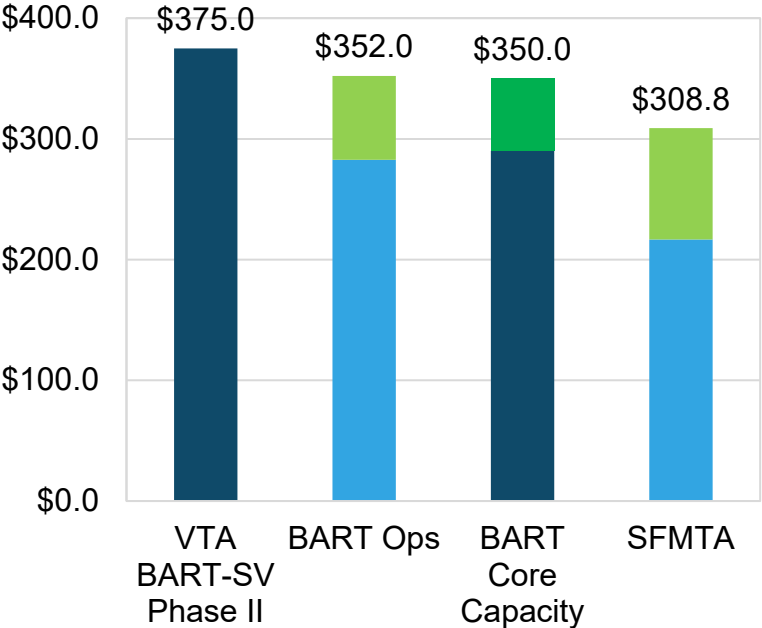

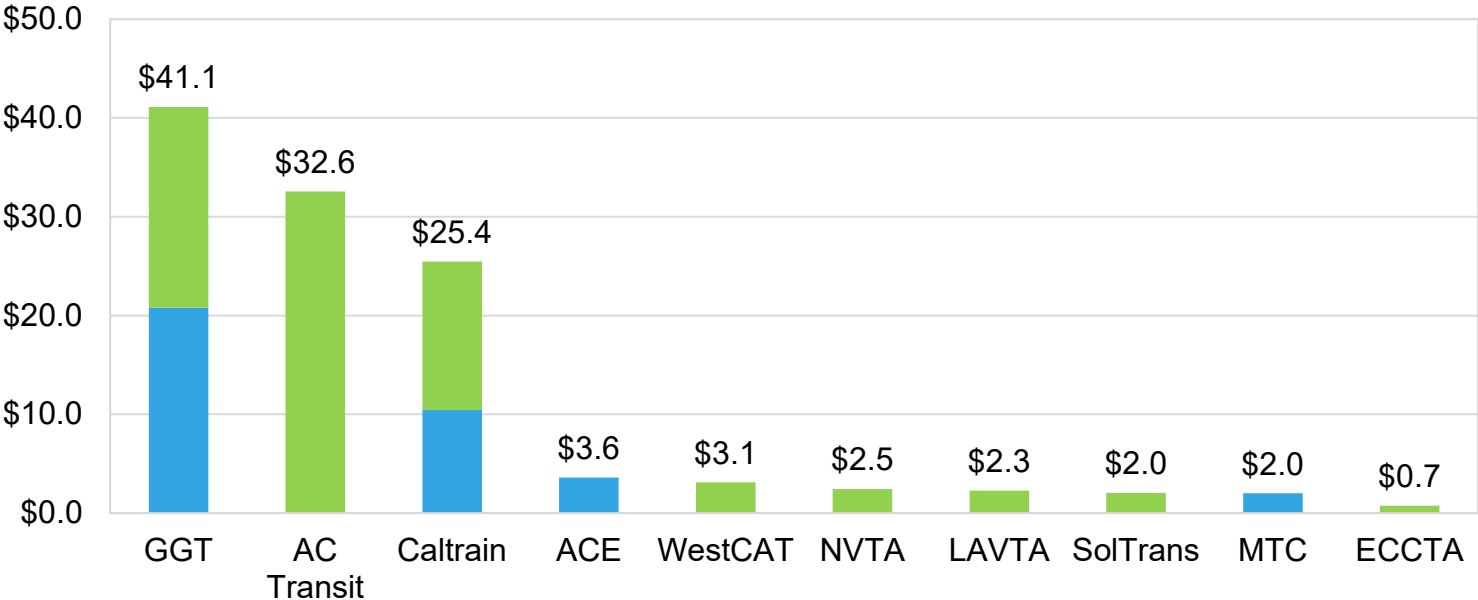
**SB 125 (\$1.2B)**      **Regional Funding Framework (\$300M)**

# SB 125 State and Regional Funding Summary

## Current Status

- \$728M in SB 125 funds received from state
  - \$407M allocated so far for FY 2024-25 and FY 2025-26 operations
- \$300M regional funding framework fully programmed
  - All \$75M in regional funds (RM3, STA) allocated
  - All \$225M in federal funds (TCP, STP/CMAQ) received approval in TIP

## Near-Term Milestones

- MTC to make \$128M in final SB 125 operating allocations (Fall 2025-Spring 2026)
- MTC to work with capital funding recipients (BART, VTA) to determine cash flow needs in advance of allocation

## Future Decisions

- Commission will make programming decisions on ~\$100M STP/CMAQ contribution, including \$7.8M swapped for TCP funds, as part of OBAG 4 framework development.

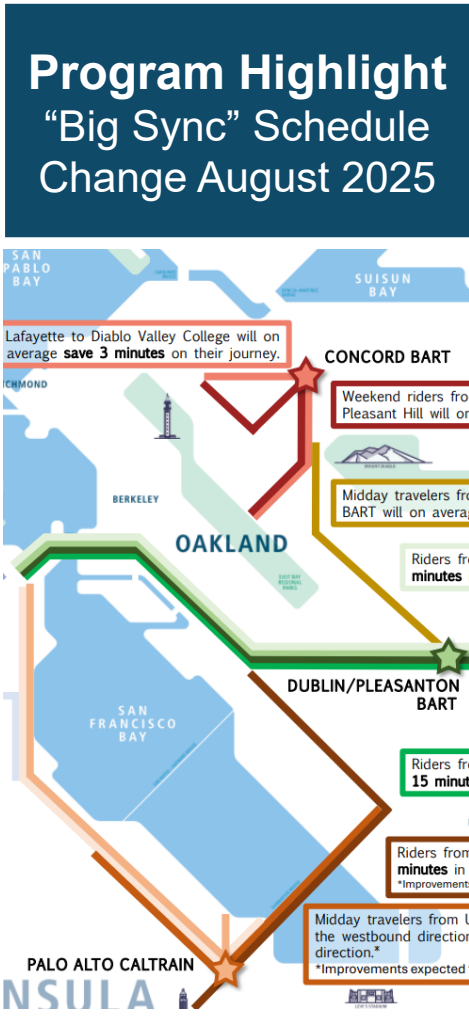

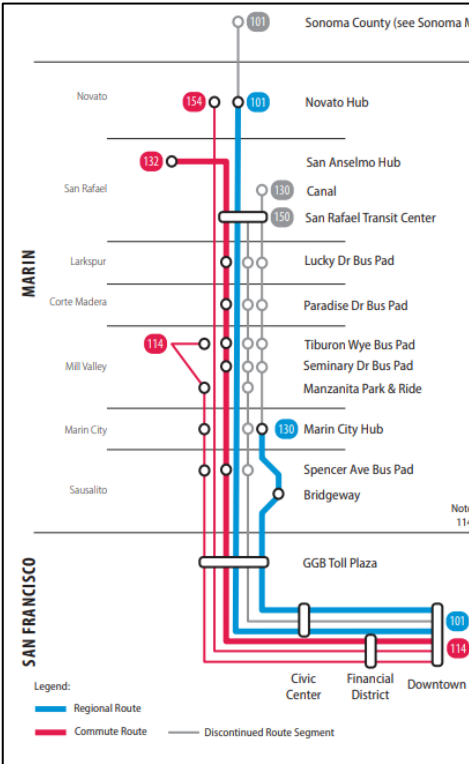

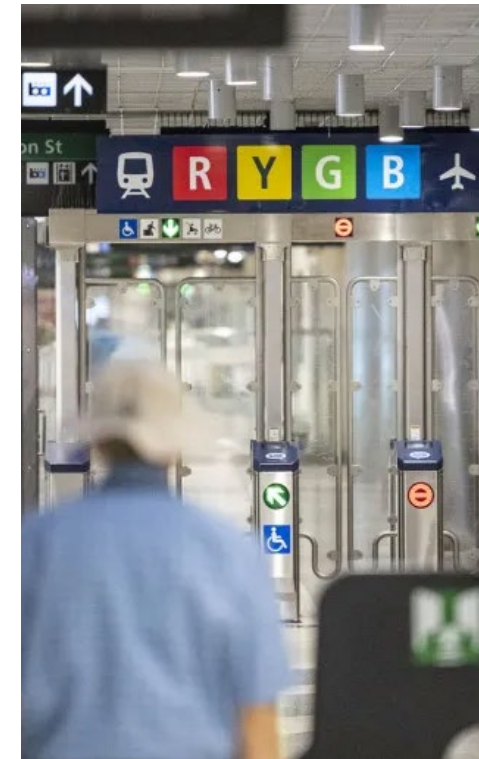

# Look Ahead: FY 2026-27 and Beyond

- Operating support from SB 125 and the Regional Funding Framework will conclude in FY 2025-26, after which some operators are projecting significant budgetary shortfalls
- Senate Bill 63 if enacted would authorize the placement of a measure on the November 2026 ballot to provide operating funds for 14 years, beginning in 2027
