

## **Local Fare Change Proposal**

### **Summary of Outreach and Communications**

AC Transit employed an extensive communications and outreach plan to inform the public of the proposed fare changes. The public was invited to submit comments in person at community meetings and public hearings, and via letter, fax and email, and via telephone to separate voicemail boxes in English, Spanish and Chinese.

The communications and outreach plan included the following tactics:

- 30,000+ trilingual brochures distributed on buses, in the Customer Service Center and in the BRT outreach center
- Trilingual handouts of presentation at community meetings
- Trilingual comment forms at community meetings

- Brochure distribution at the Chinatown Lunar New Year Festival
- Legal notice of public hearings published in Bay Area News Group (*East Bay Times*, *Argus*, *Daily Review*), Post News Group (*El Mundo*), and Sing Tao Daily
- *East Bay Times* ¼ page ad 1/20/19 and 1/27/19 (35,000 circulation/71,855 est readership per week)

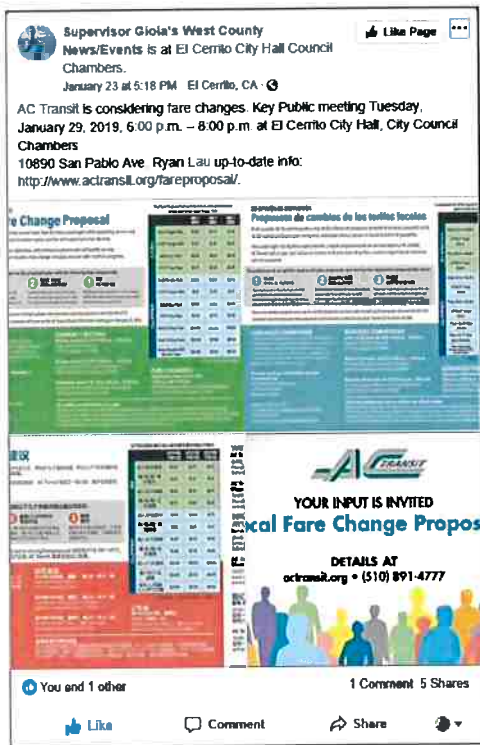

## Public Comments Received

Written comments received will be provided to the Board separately.

### Summary of the Community Meeting in Hayward (1/28/19)

Staff presented to a group of 17 members of the public. After the presentation, there were a few questions for staff about the Local Fare Change Proposal. 4 written comments were received. All comments were opposed to the fare increase, 2 comments liked the idea of Clipper discounts.

### Summary of the Community Meeting in El Cerrito (1/29/19)

Staff presented to a group of five members of the public. After the presentation, there were a few questions for staff about the fare policy. No written comments were received.

### Summary of the Community Meeting in Oakland at the GO (1/30/19)

Staff presented to a group of seven members of the public. After the presentation, there were questions for staff regarding the fare policy. 15 written comments were received. Some members of the public brought in comments from others who were unable to attend. All comments were opposed to the fare increase.

### Summary of Accessibility Advisory Committee (AAC) Meeting (2/12/19)

Staff presented to eight AAC members and three members of the public. There were a few questions for staff after the presentation regarding Clipper and the mobile fare application. One written comment was received.
