# Public Safety and the Transit Board: Lessons Learned from Chatsworth

Transit board member orientation to system safety and preparedness for serious events is a responsibility sometimes overlooked until tragedy strikes. The Chatsworth train collision occurred at 4:22 p.m. PDT Friday, September 12, 2008, when a Union Pacific freight train and a Metrolink commuter train collided head-on in the Chatsworth district of Los Angeles, California, causing mass casualties.

## **Cybersecurity Update: What Board Members Need to Know**
